The regular monthly meeting of the Kansas Governmental Ethics Commission was called to order at 1:01 p.m. by Chairman Hale.

Minutes

After review of the agenda and the November 29, 2023, meeting minutes, Chairman Hale asked for any needed corrections to the agenda and the minutes as written, or a motion to approve the agenda and minutes as written. Mr. Krull moved to approve the agenda and minutes. Mr. Hellmer seconded the motion. The motion passed unanimously.

Executive Director's Report

Mr. Skoglund presented the status report for January 10, 2024, Receipts and Expenditures Report. Every candidate, committee, and lobbyist owed a report on January 10, 2024. As of the meeting, 790 total candidates were required to file a report with 35 reports were still outstanding, 182 party committees were required to file a report with 15 reports still outstanding, and 227 political action committees were required to file a report with 18 still outstanding. Discussion ensued.

Mr. Skoglund then verbally presented an update on the Lobbyist Employment and Expenditures Reports. As of the meeting, 1,079 of the 1,082 Employment and Expenditures Reports required to be filed on January 10, 2024, were filed.

Civil Penalty Waiver Discussion

Ms. Bull-Stewart presented the guidance document, how it incorporates the forms for ease of public use, and the redaction policy with the financial Hardship declaration and Waiver Request Form. Chairman Hale asked if the goal of this presentation was to adopt the Guidance Document and two forms, which Mr. Skoglund confirmed. Mr. Krull made the motion to adopt the Civil Penalty Guidance Document, the Waiver Request Form, and the Financial Hardship Declaration. Ms. Deterding seconded the motion. The motion passed unanimously.

Civil Penalty Waiver Requests

Mr. Skoglund requested an administrative waiver for Linda Snyder. There was confusion about if she was the assigned treasurer of a political committee and the treasurer could not be identified. Mr. Solbach moved to waive the \$300 civil penalty. Mr. Krull seconded the motion. Discussion ensued. The motion passed unanimously.

Mr. Skoglund present a waiver request from Ciara Chaney, Candidate for City Council, who was assessed a \$500 civil penalty at the August 23, 2023, meeting for failing to file the July 24, 2023, Receipts and Expenditures report in a timely manner. Discussion ensued. There was no motion.

Mr. Skoglund presented a waiver request from Shelia Davis, Candidate for Mayor, who was assessed a \$1,000 civil penalty at the November 29, 2023, meeting for failing to file the October 30, 2023, Receipts and Expenditures report in a timely manner. Discussion ensued. Mr. Harrison posited if she could be allowed to submit the Waiver Request Form and Financial Hardship Declaration. Mr. Harrison moved to continue the waiver request to the February 28, 2024, meeting to allow Ms. Davis time to submit the forms. Mr. Schoenhofer seconded the motion. The motion passed with Mr. Burger and Ms. Deterding voting no.

Mr. Skoglund presented a waiver request from Erika Devore, Lobbyist for Kansas Recreation and Park Association, who was assessed a \$200 civil penalty at this meeting for failing to file the January 10, 2024, Lobbyist Employment and Expenditures Report in a timely manner. Mr. Solbach made the

motion to waive \$100 of the civil penalty if the remaining \$100 was paid within thirty (30) days. The motion died for lack of a second.

Mr. Skoglund presented the waiver requests for Bob Reese and Marsha Reese, which were submitted together. Mr. Reese and Ms. Reese were each assessed a civil penalty of \$300 at the March 22, 2023, meeting for failing to file the January 10, 2023, Receipts and Expenditures Report for Mr. Reese's State Representative campaign in a timely manner. No motion was made for either waiver request.

Mr. Skoglund presented a waiver request for Jenny Webster, Candidate for City Council, who was assessed a \$550 civil penalty at the November 29, 2023, meeting for failing to file the October 30, 2023, Receipts and Expenditures Report in a timely manner. Discussion ensued. Mr. Schoenhofer moved to waive \$275 of the civil penalty if the remaining \$275 was paid within thirty (30) days. Mr. Solbach seconded the motion. Further discussion ensued. The motion passed with Ms. Deterding, Ms. Dengler, and Mr. Burger voting no.

Prior to proceeding with the next item on the agenda, Mr. Skoglund noted that this would be the last meeting where the Civil Penalty Waiver Guidance Document would not be enforced and that, moving forward, the civil penalty waiver requests would be submitted through the requisite forms.

Public Hearing

A Motion for Continuance in Complaint No. 755, Mark Skoglund v. Scott Hamblin, was submitted by the complainant. Mr. Solbach moved to grant the Motion for Continuance. Mr. Hellmer seconded the motion. The motion passed unanimously.

The public hearing for Complaint No. 755 will occur on February 28, 2024.

Executive Session

At 1:36 p.m., Mr. Krull stated "I move that the Commission recess this open meeting, with conflict counsel, Jay Rodriguez, present, to discuss matters related to confidential investigations pursuant to K.S.A. 25-4165 and K.S.A. 25-4161 and for good cause as provided by K.A.R. 19-6-2. Justification for recess is so the Commission can exercise quasi-judicial functions when deliberating matters relating to said confidential investigations, as contemplated by K.S.A. 75-4318(g)(1). The open meeting shall be resumed here at 2:00 p.m." Mr. Solbach seconded the motion. The motion passed unanimously.

Upon return from executive session, Mr. Burger moved to dismiss Complaint Nos. 762, 763, 764, and 765. Ms. Deterding seconded the motion. The motion passed unanimously.

Mr. Burger moved to find sufficiency in Complaint Nos. 761, 766, 767, and 768. Mr. Solbach seconded the motion. The motion passed unanimously.

Mr. Hellmer moved to continue Complaint No. 760 to the February 28, 2024, meeting, that Mr. Skoglund provide notice to interested parties in this matter, for the hearing to be a status matter only with no action taken or contemplated, and that Mr. Skoglund provide any further relevant information to the commission of further contact in regard to this complaint. Mr. Solbach seconded the motion. Ms. Bull-Stewart asked for clarification. The motion passed unanimously.

Synopsis: Campaign contributions processed by a third-party payment processor must be attributed to the person who made such contributions and any processing fees associated with such contribution must be reported as expenditures on any relevant campaign finance reports.

Cited herein: K.S.A. 25-4143; K.S.A. 25-4148; K.S.A. 25-4153a; K.S.A. 25-4154.

Dear Representative Poskin:

In response to your February 26, 2024, email request, this opinion is provided by the Kansas Governmental Ethics Commission ("Commission"), concerning application of the campaign finance act, K.S.A. 25-4101 et seq. The Commission's jurisdiction is limited to applicability of this law. This opinion, provided pursuant to K.S.A. 25-4159, does not address whether some other statutory system, common law theory, agency rule or regulation applies to your inquiry.

FACTUAL STATEMENT

We understand that several legislators have received unsolicited checks processed by Democracy Engine, LLC ("Democracy Engine") during the current Legislative Session. Democracy Engine is a donation processing platform where donors can use Democracy Engine's website to contribute to various candidates or committees all at once even if candidates are in different states. Essentially, Democracy Engine facilitates contributions to campaigns through its website in a manner that it refers to as "complex donation processing" so that individuals or entities only need to go to Democracy Engine's website rather than directly contributing to various candidates.

The contribution checks received do not identify the donor making the contribution and instead state, in the upper lefthand corner, "Democracy Engine LLC, Transfer Account"; however, the check is accompanied with instructions on how to access the donation data for the donor(s). Democracy Engine's website indicates that information, such as the donor's employer, address, and occupation, are available to candidates through a data file that can be provided upon request.

However, to access the data file, a candidate must first create a log in for Democracy Engine's website.

QUESTIONS

- 1. Generally, can candidates accept contributions processed by Democracy Engine LLC?
- 2. Can candidates accept contributions processed by Democracy Engine LLC during the legislative session?
- 3. How should contributions processed by Democracy Engine LLC be reported on campaign finance reports?

ANALYSIS AND OPINION

K.S.A. 25-4143(f)(1)(A) defines a "contribution" as "[a]ny . . . payment of money or any other thing of value given to a candidate, candidate committee, party committee or political committee for the express purpose of nominating, electing or defeating a clearly identified candidate for a state or local office[.]" Additionally, K.S.A. 25-4143(k) defines person as "any individual, committee, corporation, partnership, trust, organization or association."

Here, the funds processed by Democracy Engine are contributions as the checks are payments of money given directly to the candidate or to their campaign (e.g., a check payable to the order of John Doe for Kansas House). The issue is if candidates are generally allowed to accept contributions that have been processed by Democracy Engine.

K.S.A. 25-4154(b) provides that: "[n]o person shall give or accept any contribution in excess of \$10 unless the name and address of the contributor is made known to the individual receiving the contribution." The initial check processed by Democracy Engine cannot be accepted by the candidate in the form identified in the facts because the name and address of the contributor is not reflected on the check nor provided to the recipient campaign at the time of the check's delivery. The facts indicate the check is written from "Democracy Engine LLC"; however, Democracy Engine is clear that it is not the person making the contribution and instead the as-yet-unidentified donor who used Democracy Engine to process their payment is making the contribution. Consequently, if the candidate were to accept any check contributing over \$10 that was processed by Democracy Engine without first discovering the donor's name and address, then that candidate would be in violation of K.S.A. 25-4154(b).

For a candidate to legally accept a contribution check over \$10 processed by Democracy Engine, the candidate must first create a log in on Democracy Engine's website and must access the data file that identifies the donor. Once the candidate has discovered the donor's name and address, then the candidate may accept the contribution check facilitated by Democracy Engine. If the candidate knows the name and address of the contributor of the funds—the person making the contribution—then accepting the contribution is lawful under K.S.A. 25-4154(b). Alternatively, the candidate can return the contribution without needing to obtain the data.

Regarding the question of if contributions processed by Democracy Engine may be accepted during the legislative session, a review of K.S.A. 25-4153a is appropriate. K.S.A. 25-4153a prohibits a legislator or candidate for membership in the legislature from accepting or soliciting a contribution from anyone other than a non-lobbyist individual "after January 1 of each year and prior to adjournment sine die of the regular session of the legislature or at any other time in which the legislature is in session[.]"

According to the facts provided, a candidate for the legislature or legislator would not be able to determine the category of person, as defined in K.S.A. 25-4143(k), contributing to their campaign by reviewing the check processed by Democracy Engine. Therefore, the legislator or candidate for the legislature must first create a log in for Democracy Engine's website to discern the identity of the contributor. If the person who used Democracy Engine to process their campaign contribution is a non-lobbyist individual, then the legislator or candidate for the legislature may accept the contribution during the regular legislative session. If the contributor is a prohibited entity, the contribution must be returned to the donor.

Finally, the issue has also arisen of how contributions processed by Democracy Engine should be reported on Receipts and Expenditures Reports. The candidate must report the source of the contribution, which is the person who used Democracy Engine to process their donation, not Democracy Engine itself. The candidate must report the full amount of the contribution, even if a portion of the donation went to processing fees associated with using Democracy Engine's service. If the candidate cannot or does not wish to obtain the contributor information from Democracy Engine, they must return the contribution. Additionally, if the candidate is able to discern what processing fees were associated with the contribution, then those fees should be reported as expenditures for Democracy Engine, LLC processing fees on any relevant campaign finance reports.

It has come to my attention that my colleagues are receiving checks from Democracy Engine, LLC and initially believed that they needed to be returned as we are not allowed to accept campaign donations during the legislative session from any entities except individuals. Upon further investigation, it appears that Democracy Engine, LLC is a donation processing platform, similar to ACT Blue, so the checks would not seem to be donations from the LLC, but from donors. The check comes with instructions on how to access the donor information. I have included an example that was received by Allison Hougland, with her express permission to share it with you.

I am writing to request your consideration in waiving the fines which have been assessed to me personally for the January lobbyist reports of Fuel True, Lamar and EKOGA.

My last day of employment with Fuel True was September 30, 2023. I was a registered lobbyist up to that point for all three organizations, but report filing had typically been handled by our accountant. In addition to all of the mailings being sent to their office, emails were routed there as well. The accountant at Fuel True has filed all of the reports in the past and I did not anticipate this would change. Since I did not work there anymore, I did not have access to any of the information necessary to file and did not receive any of the notifications.

In a conversation with Jessica at KGEC after I received my notice January 29, 2024, she had also spoken with the Fuel True office. Fuel True said the Failure to File notice was not delivered to them until January 29.

There was no intent to mislead or deceive the Ethics Commission or the public and I am certain there was little to no financial activity from any of the three entities during the filing period after I was let go.

Due to my dismissal on September 30, the delay in mail and email correspondence, the filings historically being handled on time by Fuel True and the lack of any intentional misinformation, I would ask for your consideration of a full waiver of fines for these three entities.

NOTICE OF PUBLIC HEARING

Now, on this 26th day of January, the Kansas Governmental Ethics Commission (Commission), which is tasked in K.S.A. 25-4119a with enforcing the Kansas Campaign Finance Act, orders a public hearing regarding Complaint No. 755.

On November 29, 2023, the Commission found probable cause to believe Scott Hamblin (Respondent) violated K.S.A. 25-4148 by failing to file the requisite campaign finance reports as alleged in the attached Complaint, No. 755. Consequently, as provided by K.S.A. 25-4161(e) and K.S.A. 25-4163(a), the Commission hereby orders a public hearing regarding Respondent's liability for the Campaign Finance Act violations alleged in Complaint No. 755.

This public hearing was initially scheduled for January 24, 2024. Prior to the hearing, the Commission's Executive Director, Mark Skoglund (Complainant), moved for a continuance of the hearing until Febrary 28, 2024, in order to ensure sufficient notice to Respondent. At their public meeting on January 24, 2024, the Commission granted the motion and agreed to continue the hearing until their next scheduled meeting, on February 28, 2024.

This public hearing is scheduled for February 28, 2024, at 1:30 p.m., in the Commission's conference room, 901 South Kansas Avenue, Topeka, Kansas 66612. Commissioner Patricia Dengler has been designated as the Presiding Officer in this matter. This hearing will be conducted in person unless Respondent requests to attend remotely, by videoconference or telephone.

Respondent must notify the Commission, in writing, by 5:00 p.m. on Monday, February 26, 2024, if he would like to attend the hearing remotely.

Pursuant to K.S.A. 25-4163(a), the hearing will be held before the Commission as a whole. Pursuant to K.S.A. 25-4161(h)(1), the hearing will be conducted in accordance with the Kansas Administrative Procedure Act (K.S.A. 77-501 *et seq.*); the hearing procedure is guided by the Commission's regulations for proceedings before the Commission (K.A.R. 19-7-1 *et seq.*).

At the hearing, the Commission will consider whether Respondent is liable for failing to file a July 24, 2023, Receipts and Expenditures Report for the reporting period of January 1, 2023 through July 20, 2023, and if so, what is the appropriate penalty.

If a party fails to attend or otherwise participate in the hearing, then that party may be held in default under K.S.A. 77-520 and a default judgment may be entered against that party.

In compliance with K.S.A. 25-4163(a), the hearing will be held before the Commission as a whole. Additionally, pursuant to K.S.A. 25-4163(a) and K.S.A. 25-4161(h)(1) the hearing shall be conducted in accordance with the Kansas Administrative Procedure Act (K.S.A. 77-501 *et. seq.*)

and the Kansas Code of Civil Procedure (K.S.A. Chapter 60), K.A.R. 19-7-1 through K.A.R. 19-7-16¹ and K.S.A. 77-513 through K.S.A. 77-532² provide the procedure for hearings conducted in front of the Commission.

The Commission will consider the following issue at the hearing, whether Respondent is liable for failing to file a July 24, 2023, Receipts and Expenditures Report for the January 1, 2023, through July 20, 2023, reporting period.

If a party fails to attend or otherwise participate in the hearing, then that party may be held in default under K.S.A. 77-520 and a default judgment may be entered against said party.

MEMORANDUM IN SUPPORT OF A FINDING OF PROBABLE CAUSE

COMES NOW, Mark Skoglund, Executive Director of the Kansas Governmental Ethics Commission (the "Executive Director"), and hereby offers the foregoing memorandum in support of a finding of probable cause for the allegations of the above complaint.

I. NATURE OF THE MATTER BEFORE THE COMMISSION.

This is a matter of a candidate who must file campaign finance reports and has not yet done so. Scott Hamblin is a candidate who served as his own treasurer for Overland Park City Council in the 2023 election. Despite receiving notice from Commission staff to do so, Mr. Hamblin has failed to file a July 24, 2023, Receipts and Expenditures Report ("July 2023 Report"). For the reasons set forth below, and pursuant to K.A.R. 19-5-7 and K.S.A. 25-4161(e), the Commission should find that there is probable cause for believing the allegations set forth in Complaint No. 755.

II. STATEMENT OF FACTS.

1. Mr. Hamblin became a candidate for the 2023 election by virtue of filing a Candidate's Declaration of Intention Filing Form of on May 26, 2023. A true and correct copy of the Hamblin

Campaign's Candidate's Declaration of Intention Filing Form is attached to this memorandum as **Exhibit 1**.

- 2. Under K.S.A. 25-4148(a)(1), Mr. Hamblin was required to file a July 2023 Report; however, he has not filed such report. Affidavit of Jennifer Schneider, ¶ 3. The Affidavit of Jennifer Schneider is attached to this memorandum as **Exhibit 2**.
- 3. Jennifer Schneider, the Commission's Local Campaign Finance Coordinator, made numerous attempts to notify Mr. Hamblin of his obligation to file the July 2023 Report, specifically: (1) on July 26, 2023, she reminded Mr. Hamblin, via email, to file a July 2023 report, and she attached a blank report form to that email; (2) on July 26, 2023, she also mailed the Notice of Failure to File the July 2023 Report, via certified mail return receipt requested, to Mr. Hamblin; and (3) on August 3, 2023, she mailed a civil penalty reminder to Mr. Hamblin, via first class mail, along with a copy of the Notice of Failure to File the July 2023 Report. Ex. 2, Schneider Aff., ¶ 4.
- 4. Mr. Hamblin has been assessed a \$1,000.00 civil penalty for failing to file the requisite report. A true and correct copy of the civil penalty assessment order is attached to this memorandum as **Exhibit 3**.

III. APPLICABLE BURDEN OF PROOF.

Probable cause exists if there is "evidence sufficient to a cause a person of ordinary prudence and caution to conscientiously entertain a reasonable belief of the accused's guilt." *State v. Berg*, 270 Kan. 237, 238, 13 P.3d 914, 915 (2000). In the context of the Commission, probable cause is "the reasonable belief that a specific [violation] has been or is being committed and that the [respondent] committed the [violation]." *State v. Abbott*, Kan. 161, 164, 83 P.3d 794, 797 (2004). Moreover, when determining whether probable cause exists, the Kansas Supreme Court considers all the circumstances, including all information available and fair inferences from such

information. State v. Abbott, 277 Kan. At 164, 83 P.3d at 797. Applied to the complaint at issue,

if the Commission reasonably believes that Mr. Hamblin has violated K.S.A. 25-4148(a), then it

should find probable cause that a Campaign Finance Act violation occurred.

IV. <u>LEGAL ARGUMENT.</u>

Treasurers are required by law to file Receipts and Expenditures Reports at various times

in an election cycle, including by "the eighth day preceding the primary election, which report

shall be for the period beginning on January 1 of the election year for the office the candidate is

seeking and ending 12 days before the primary election, inclusive[.]" K.S.A. 25-4148(a)(1).

Commission staff complied with K.S.A. 25-4152 and followed up with Mr. Hamblin to

secure compliance. Ex. 2, Schneider Aff., ¶ 4. When considering the circumstances, the

Commission should find that there is probable cause regarding the allegations of the complaint

because Mr. Hamblin, as his own treasurer for the 2023 election, was required to file the July 2023

Report and failed to do so.

V. CONCLUSION.

Should Mr. Hamblin file the July 2023 Report prior to a hearing date, the Executive

Director will support dismissal of the complaint. The goal in this matter, as is common with Failure

to File instances, is to secure filing. However, the report remains unfiled; therefore, a finding of

probable cause is appropriate.

Dear Mr. Hamblin:

The Governmental Ethics Commission met on August 23, 2023, to determine what its action should be regarding your failure to file your July 24, 2023, Receipts and Expenditures Reports in a timely manner.

Following a review of your file by the Commission, they discussed the possible assessment of the civil penalty provided for by K.S.A. 25-4152. The statute provides for the automatic assessment of a civil penalty of \$100 for the first day and \$50 per day thereafter, up to a maximum of \$1,000, for the late filing of a required form. The Commission may waive part of, or all the civil penalty. **The Commission is assessing you a civil penalty of \$1,000**. The official order assessing the civil penalty is enclosed. Please send the payment to the Commission's office and we will forward it to the State Treasurer.

The Commission's rules and regulations state that any person who is assessed a civil penalty may request a waiver of the penalty. The Commission would have to receive such a request within thirty days after you have received the enclosed assessment order pursuant to K.A.R. 19-4a-1. If you do plan to request a waiver of the civil penalty, you must provide the Commission with a letter requesting the waiver and explaining the reasons why you believe the Commission should waive the civil penalty. Your letter should indicate if you want to be present to address the Commission in person. The Commission will consider your letter request for waiver during the next regularly scheduled Commission meeting. If your waiver request indicates you want to address the Commission in person, you will be advised in advance of the time and place of the Commission meeting.

CIVIL PENALTY ASSESSMENT ORDER

On the 23rd day of August 2023, the Commission found that Scott Hamblin, Candidate for City Council, failed to file the July 24, 2023, Receipts & Expenditures Report as required by K.S.A. 25-4148 in a time period specified in the notification of failure to file sent by certified mail.

Scott Hamblin is hereby directed to pay the State of Kansas a civil penalty of one thousand dollars (\$1,000). The basis for computation, which is \$100 for the first day and \$50 per day the report remains unfiled thereafter up to a maximum of one thousand dollars (\$1,000) as set forth in K.S.A. 25-4152.

The Executive Director shall serve this order in the same manner as the notification of failure to file. As provided by the Kansas Act for Judicial Review, K.S.A. 77-601 et seq., judicial review of this order may be had by filing a petition with the appropriate district court. Such petition for judicial review shall be served upon Mark Skoglund, Executive Director for the Commission at the above address.
