The monthly meeting for the Kansas Governmental Ethics Commission was called to order at 1:00 p.m. by Chairman Hale.

#### Minutes

After review of the agenda and the May 22, 2024, meeting minutes, Chairman Hale asked for a motion to approve the agenda and minutes as written, unless anyone could identify any corrections. Mr. Glynn moved to approve. Mr. Hellmer seconded the motion. The motion passed unanimously.

### Introduction of new Commissioner

Introductions of Commissioners and staff who were in attendance occurred.

#### **Executive Session**

At 1:05 p.m., Mr. Glynn stated, "I move that the Commission recess this open meeting to executive session, with Office Manager Payge Quintana-Padgett; Executive Director Mark Skoglund; General Counsel Kaitlyn Bull-Stewart; and Conflict Counsel Jesse Burris present, to discuss matters related to potential federal court litigation and for good cause as provided by K.A.R. 19-6-2. Justification for executive session is so the Commission can consult with its attorney regarding matters that would be deemed privileged in the attorney-client relationship, as contemplated by K.S.A. 75-4319(b)(2). The open meeting shall be resumed here at 1:17 p.m." Ms. Ramirez seconded the motion. The motion passed unanimously.

The Commission returned to open session at 1:17 p.m.

# **Advisory Opinion**

Ms. Bull-Stewart provided a synopsis for Advisory Opinion 2024-02, which was requested by Mr. John Cozine. The request pertained to lobbyist registration and gift exceptions in Chapter 46 and

whether EdChoice, a nonprofit organization that promotes state programs to expand school choice policies, fit within the element test established by K.S.A. 46-237(h). Discussion ensued.

The Commission requested additional information be provided by Mr. Cozine prior to coming to a determination. Further discussion ensued.

# General Counsel's Update

Ms. Bull-Stewart first discussed the four applicable proof thresholds - reasonable suspicion, sufficiency, probable cause, and clear and convincing. Discussion ensued among the Commissioners.

Secondly, Ms. Bull-Stewart discussed how Commission complaint proceedings could coincide with criminal prosecution. Further discussion ensued among the Commissioners.

Lastly, Ms. Bull-Stewart discussed how the Office of Administrative Hearings handles default matters since the recent civil fine hearings have been default proceedings. Further discussion ensued among the Commissioners.

# **General Topics**

Mr. Skoglund presented Policy 2024-01 and Policy 2024-02 to the Commission. Policy 2024-01 discussed restrictions on recordings of Commission meetings under the Kansas Open Meetings Act. Policy 2024-02 discussed the process of making a Kansas Open Records Act request of the Commission. Discussion ensued. Mr. Hellmer moved to adopt Policy 2024-01 and Policy 2024-02 with the amendments discussed. Mr. Burger seconded the motion. The motion passed unanimously.

# Civil Fine Hearings

Ms. Bull-Stewart requested dismissal of Complaint Nos. 772 and 773 since the outstanding Receipts and Expenditures Reports for the campaign had been filed and compliance was achieved. Discussion ensued. Mr. Jackson moved to adopt the proposed orders of dismissal. Mr. Glynn seconded the motion. The motion passed unanimously. Ms. Bull-Stewart requested a motion to authorize Mr. Hellmer to sign both orders of dismissal. Mr. Burger made the motion. Mr. Glynn seconded the motion. The motion passed unanimously.

Ms. Bull-Stewart requested to continue the prehearing conferences and hearings in Complaint Nos. 774, 775, and 777 for service issues. Mr. Glynn made the motion. Ms. Ramirez seconded the

Ms. Bull-Stewart requested that Mr. Skoglund be sworn in to provide testimony regarding the outstanding reports. Mr. Hellmer granted that request. Ms. Quintana-Padgett swore in Mr. Skoglund to which Mr. Skoglund responded in the affirmative. Ms. Bull-Stewart asked Mr. Skoglund to walk through the allegations of the complaint. penalties and had a \$5,000.00 fine previously imposed for failing to file the January 2022 Receipts and Expenditures Report. Discussion ensued. Mr. Burger moved to fine Mr. Williams \$2,000.00 with a total reduction if the outstanding reports are filed within thirty days. Ms. Ramirez seconded the motion. The motion passed unanimously.

Mr. Hellmer asked for a motion to authorize him to sign the order for Complaint No. 770. Mr. Burger made the motion. Ms. Ramirez seconded the motion. The motion passed unanimously.

Synopsis: A person must register as a lobbyist in Kansas if they expend more than \$1,000.00 for lobbying on behalf of a client, regardless of whether the legislature is in session. The process for a nonprofit organization to register a lobbyist is no different than the process for any other person under K.S.A. 46-265. EdChoice does not fall within the narrow K.S.A. 46-237(h) exception for entities established to serve, inform, educate, and strengthen legislatures in all states. However, Kansas legislators who attend EdChoice's annual program may accept meals pursuant to K.S.A. 46-237(d).

Dear Mr. Cozine:

In response to your May 7, 2024, email request, this opinion is provided by the Kansas Governmental Ethics Commission ("Commission"), concerning application of the state governmental ethics law, K.S.A. 46-214a *et seq*. The Commission's jurisdiction is limited to applicability of this law. This opinion, provided pursuant to K.S.A. 46-254, does not address whether some other statutory system, common law theory, agency rule, or regulation applies to your inquiry.

#### **FACTUAL STATEMENT**

EdChoice is a 501(c)(3) nonprofit organization that promotes state programs to expand school choice policies. EdChoice offers an "annual educational program" to which all Kansas legislators may be invited to. Legislators may participate in the program by offering their opinions on educational choice policies and how such policies have impacted Kansas. EdChoice would like to pay for the invited Kansas legislators to attend its annual program. This would include covering travel, lodging, food, and beverage for the legislators.

#### **QUESTIONS**

- 1. If EdChoice exceeds the \$1,000.00 registration threshold within K.S.A. 46-222(a)(3), is EdChoice required to register a lobbyist even if the legislature is no longer in session when the expenditures are made?
- 2. If EdChoice is required to register a lobbyist, do any additional steps need to be taken to register a nonprofit organization as opposed to registering any other person?
- 3. Would EdChoice be permitted to pay for Kansas legislators' travel, lodging, food, and beverage under the K.S.A. 46-237(h) exception?

#### ANALYSIS AND OPINION

K.S.A. 46-222(a) lists four actions that could render a person a "lobbyist" under Kansas law. Relevant here, K.S.A. 46-222(a)(3) states that a lobbyist includes "any person who makes expenditures in an aggregate amount of \$1,000 or more, exclusive of personal travel and subsistence expenses, in any calendar year for lobbying[.]" K.S.A. 46-223 defines "person" to mean "an individual, proprietorship, partnership, limited partnership, association, trust, estate, business trust, group, or corporation, whether or not operated for profit, or a governmental agency unit, or subdivision." Finally, K.S.A. 46-265 requires every lobbyist in Kansas to register with the Secretary of State.

EdChoice, as a nonprofit organization, is a "person" under K.S.A. 46-223. The first question posed is whether EdChoice expending over \$1,000.00 on lobbying outside of the duration of the regular session changes whether it must register a lobbyist.

The test of K.S.A. 46-222(a)(3) is indifferent to whether the Legislature is in session or not. The only deciding factor is whether the \$1,000.00 expense threshold for lobbying is exceeded. The question, as posed, indicates that \$1,000.00 would be expended for lobbying. Consequently, if EdChoice exceeds the \$1,000.00 registration threshold within K.S.A. 46-222(a)(3), then it must register as a lobbyist with the Kansas Secretary of State.

Additionally, a nonprofit organization does not register any differently than any other person under Kansas law. EdChoice must select an individual representative to register as a lobbyist in Kansas and that representative would list EdChoice as the "person compensating the lobbyist for lobbying" pursuant to K.S.A. 46-265(a).

Finally, regarding your gift question, K.S.A. 46-237 provides, in pertinent part:

Except as provided by this section, no state officer or employee, candidate for state office or state officer elect shall accept, or agree to accept any:

(1) economic opportunity, gift, loan, gratuity, special discount, favor, hospitality or service having an aggregate value of \$40 or more in any calendar year . . . from any one person known to have a special interest, under circumstances where such person knows or should

know that a major purpose of the donor is to influence such person in the performance of their official duties or prospective official duties.

As mentioned above, EdChoice, as a nonprofit organization, is a "person" as defined by K.S.A. 46-223. K.S.A. 46-228 defines "special interest" to mean "an interest of any person concerning action or non-action by the legislature on any legislative matter affecting such person as distinct from affect upon the people of the state as a whole." Based on EdChoice's policy advocacy, EdChoice has a special interest concerning action or nonaction by Kansas legislators.

There are exceptions to the gift prohibition for legislators, with one such exception being K.S.A. 46-237(h), which relevantly provides:

... but nothing in this act ... shall be construed to prohibit any legislator from accepting reimbursement for actual expenses for travel, subsistence, hospitality, entertainment and other expenses incurred in attending and participating in meetings, programs and activities sponsored by . . . any national, nonprofit, nonpartisan organization established for the purpose of serving, informing, educating and strengthening state legislatures in all states of the nation, when paid from funds of such organization and nothing shall be construed to limit or prohibit the expenditure of funds of and by any such organization for such purposes.

Two requirements must be met for an organization to fit its gift under the exception: (1) the organization must be a national, nonprofit, nonpartisan organization and (2) the organization must be established for the purpose of serving, informing, educating, and strengthening state legislatures in all states.

The Commission has previously interpreted K.S.A. 46-237(h) narrowly. In Advisory Opinion 2012-09, the Commission considered whether K.S.A. 46-237(h) applied to scholarships offered to Kansas legislators by the Foundation for Government Accountability. In addition to finding that the Foundation failed to satisfy the national organization requirement, the Commission also found that the Foundation failed the exception's second requirement because the Foundation was not established for the purpose of serving, informing, educating, and strengthening state legislatures in all states.

Applying the narrow K.S.A. 46-237(h) exception to EdChoice, it appears that EdChoice is likely a national nonprofit organization because it regularly interacts with legislatures of most states. Thus, EdChoice likely meets the first requirement for the exception.

Regarding the second requirement of the exception, based on the additional information submitted by EdChoice, it does not appear that EdChoice was established to serve, inform, educate, and strengthen legislatures in all states. Instead, EdChoice was established to advocate for certain education policies. "Serving, informing, educating and strengthening" is specific and narrow language and a national, nonprofit, nonpartisan organization seeking the K.S.A. 46-237(h) exception must have been established for all four reasons.

For the foregoing reasons, the Commission finds that EdChoice does not meet the K.S.A. 46-237(h) exception. So, Kansas legislators may not be offered, nor may they accept the payment of their travel and lodging to the EdChoice annual program.

K.S.A. 46-237(d), however, offers an additional exception that allows for the gifting of food and beverages. Specifically:

Hospitality in the form of food and beverages is presumed not to be given to influence a state officer or employee, candidate for state office or state officer elect in the performance of official duties or prospective official duties . . . except when a particular course of official action is to be followed as a condition thereon.

So long as no course of official action is conditioned on the giving of the food or beverage to the legislators, then EdChoice may pay for the food and beverages that the Kansas legislators receive at the annual program and not run afoul of the general gift prohibition of K.S.A. 46-237.

To whom it may concern:

I am respectfully writing to request an advisory opinion on behalf of a client that currently does not have lobbyists registered to lobby on its behalf in Kansas. Please let me know if you require any additional information.

#### Request:

In light of the registration requirements in Kansas, and the gift provisions and exceptions applicable to legislators and organizations, we request an advisory opinion to assist in determining whether registration as an entity is required under the lobbying laws, and whether travel, lodging, food and beverage may be paid for by a non-profit organization sponsoring educational programs for legislators in most\* states.

#### Background:

Our client, EdChoice, is a 501(c)(3) nonprofit, nonpartisan organization which promotes state programs that expand educational opportunities for as many students as possible. As part of this goal, EdChoice offers an annual educational program to which all legislators from most\* states are invited to learn about educational choice. The event is structured as a classroom setting, and experts in various areas of education (e.g., history of education in the US, legal history and constitutional issues, budgeting and fiscal matters, educational outcomes, accountability, regulation) instruct legislators. Legislators may speak to educational choice legislation that was successful, or not, in their own states as conversation in shared experiences; what works, what doesn't work. No pending or "in progress" legislation in any state is discussed during these programs. Where permitted by state ethics laws, EdChoice pays for the economy travel, reasonable lodging, food and beverage of the attendees.

Under Kansas lobbying law, a *lobbyist* is, among other things, any person who makes expenditures in an aggregate amount of \$1,000 or more, exclusive of personal travel and subsistence expenses, in any calendar year for lobbying [K.S.A. §46-222(a) (3)]. The definition of *lobby* includes entertaining any state officer or employee or giving any gift, honorarium or payment to a state officer or employee in an aggregate value of \$40 or more within any calendar year, if at any time during such year the person supplying the entertainment, gifts, honoraria or payments has a financial interest in any contract with, or action, proceeding or other matter before the state agency in which such state officer or employee serves, or if such person is the representative of a person having such a financial interest [K.S.A. §46-225(a)(3)]. While EdChoice does not promote or oppose legislative action during its program, it is possible EdChoice may have an eventual interest in legislation introduced in the legislature during future calendar years. Due to that possible future interest, and due to the number of legislators from Kansas expected to attend the program and accept travel, lodging, and food, EdChoice believes it may be required to register.

#### Questions:

1. Even if EdChoice exceeds the \$1,000 registration threshold, is registration required if the legislature is no longer in session when the program is held, thus making it unlikely legislation in which EdChoice would have a possible interest would be introduced during that year?

- 2. If registration is required, is there a mechanism for registering as a non-profit entity? Would any special steps need to be taken compared to the process for registering an individual as a lobbyist?
- 3. Regardless of whether registration is required, K.S.A. §46-237 limits gifts and other payments legislators may accept. However, subsection (h) permits legislators to accept, and organizations are permitted to expend, reimbursement for actual expenses for travel, subsistence, hospitality, entertainment and other expenses incurred in attending and participating in meetings, programs and activities sponsored by any national, nonprofit, nonpartisan organization established for the purpose of serving, informing, educating and strengthening state legislatures in all states of the nation, when paid from funds of such organization. Would EdChoice, as a nonprofit formed to educate legislators and citizens in all states on the policy of school choice, be permitted to provide reimbursement to legislators under this exception?

\*States with severe or total restrictions against travel, or which have limited interest or need to learn about school choice, may not be included. For each invited state, all legislators are invited.

#### I. Fiscal Year 2025 – Change from Approved

The agency's revised FY 2025 budget totals \$863,869, which includes \$560,050 from the State General Fund. This request is an increase of \$5,266 (0.6%) above the approved amount, but due to a reappropriation – unused funds - from FY 2024 of the same amount, no additional funding is necessary. The most significant changes are categorized below:

#### Reductions

- Database fees due to termination of a contract (-\$6,024),
- Commission mileage due to some Commissioner preference to attend virtually and reflecting current usage (-\$3,356),
- Printing based on updated plans (-\$1,500), and
- Internet and phone updated pricing (-\$507).

#### <u>Increases</u>

- Employee parking, paid for with reductions elsewhere in the budget (\$7,542),
- Janitorial service for the office due to a transition in building management (\$2,756),
- Postage costs reflecting increases in price (\$2,000),
- Software to support campaign finance database infrastructure (\$1,628),
- Office 365 costs and computer replacements (\$866),
- Meals and lodging for the COGEL conference based on actual locality data (\$641), and
- Water cooler increased costs (\$550).

Fringe benefits also includes adjustments (e.g., agency KPERS costs increase by \$590) but they are largely offset by other salary and wage fringe benefit changes. In total, fringe benefit changes are a reduction of \$148 below the approved amount.

The budget also includes some recategorization of expenses. For example, an increase of \$8,500 for attorneys is offset by a corresponding decrease in "other contractual services" which is where that line item had previously been budgeted.

#### II. Fiscal Year 2026

The agency's FY 2026 budget totals \$877,355, an increase of \$13,486 (1.6%) above the FY 2025 request. The increase is attributable to rent and health insurance costs largely out of the control of the agency. The most significant changes are:

#### **Reductions**

- Postage due to decreased need in less active election cycle (-\$6000),
- Software to support campaign finance database infrastructure since it is a one-time cost in FY 2025 (-\$1,220), and
- Meals and lodging for the COGEL conference since the December 2025 conference location has yet to be announced, so standard US rates are used for budgeting purposes (-\$573).

#### <u>Increases</u>

- Building rent due to the completion of the current lease (\$12,557),
- Agency-funded health insurance (\$7,327),
- The Monumental Building Surcharge, an amount that is charged to all state agencies in Shawnee County (\$4,236),
- Commissioner mileage reverting to standard budgeting (\$1,268), and
- Agency KPERS contributions (\$690).

#### III. Fiscal Year 2027

The agency's FY 2027 budget totals \$889,344, an increase of \$11,989 (1.4%) above the FY 2026 request. The increase is largely attributable to increased health insurance costs, postage costs, and the Monumental Building Surcharge. The most significant changes are:

#### **Reductions**

• Agency KPERS contributions (-\$1,773).

#### Increases

- Agency-funded health insurance (\$7,261),
- Postage due to increased need in statewide and House election cycle (\$2,000),
- The Monumental Building Surcharge, an amount that is charged to all state agencies in Shawnee County (\$1,765),
- Computer replacements and increased Office 365 costs (\$1,330),
- Meals and lodging for the COGEL conference based on average current locality rates for Canada (\$1,145).

# IV. Enhancement Package – FY 2026 - FY 2027

Due to space constraints in the current office, the end of our current lease and subsequent expected rent increases in FY 2026, and the significant benefit that would accrue to the public with additional staff, the following enhancement package is submitted for consideration.

Office relocation - Commission staff currently occupy every possible space for an office, including our investigator utilizing a very small space. No hiring of additional staff is possible without a relocation.

New attorney - State agencies with regulatory enforcement roles benefit substantially from having a division of labor between multiple attorneys – one who handles enforcement and litigation, and another who primarily provides compliance guidance and serves the board. Currently, the overlap between these responsibilities creates logistical, planning, and legal issues, and the workload in both areas has increased substantially over the preceding five years.

New full-time investigator – The investigation workload has increased substantially over the preceding six years both in quantity and complexity. While we are lucky to have a very talented part-time investigator, hiring an additional full-time investigator would provide the necessary support to rapidly resolve investigation needs. In a possible future scenario with a decreased investigatory caseload, this position would serve as an auditor, assisting campaign finance compliance staff.

The requested enhancement would be funded from the State General Fund as follows:

# C. Complainant alleges:

# Failure to File January 2024 Report

- 1. Brad Boyd was a candidate for state representative in the 2022 election cycle and also served as his own treasurer after his former treasurer resigned on January 22, 2024. Mr. Boyd was required to file a Receipts and Expenditures Report for the applicable time periods under K.S.A. 25-4148(a); however, no such report was filed.
- 2. On January 23, 2024, the Commission sent notice, via certified mail return receipt requested, to Mr. Boyd notifying him of the requirement to file a January 10, 2024, Receipts and Expenditures Report ("January 2024 Report").
- 3. The notice further stated that failure to file the January 2024 Report may be punishable as a class A misdemeanor.

- 4. Finally, the notice informed Mr. Boyd that he had until February 7, 2024, to file the January 2024 Report to comply with the reporting requirements to avoid a civil penalty being assessed against him.
- 5. Notwithstanding the notice of the filing requirement under K.S.A. 25-4148, Mr. Boyd has failed to file the January 2024 Report.

WHEREFORE, Complainant respectfully requests the Commission find Respondent, Brad Boyd, liable under the Kansas Campaign Finance Act for failing to file the report required by K.S.A. 25-4148, and that the Commission impose a fine pursuant to K.S.A. 25-4181, in an amount not to exceed \$5,000 for the first violation, \$10,000 for the second violation and \$15,000 for the third violation and for each subsequent violation.

# C. Complainant alleges:

# Failure to File January 2024 Report

- 1. Stephanie Yeager was a candidate for state representative in the 2020 election cycle. Ms. Yeager's treasurer was required to file a Receipts and Expenditures Report for the applicable time periods under K.S.A. 25-4148(a); however, despite being responsible for filing such report under K.S.A. 25-4152(a), no such report was filed.
- 2. On January 23, 2024, the Commission sent notice, via certified mail return receipt requested, to Ms. Yeager notifying her of the requirement to file a January 10, 2024, Receipts and Expenditures Report ("January 2024 Report").
- 3. The notice further stated that failure to file the January 2024 Report may be punishable as a class A misdemeanor.

- 4. Finally, the notice informed Ms. Yeager that she had until February 7, 2024, to file the January 2024 Report to comply with the reporting requirements to avoid a civil penalty being assessed against her.
- 5. Notwithstanding the notice of the filing requirement under K.S.A. 25-4148, Ms. Yeager has failed to file the January 2024 Report.

WHEREFORE, Complainant respectfully requests the Commission find Respondent, Stephanie Yeager, liable under the Kansas Campaign Finance Act for failing to file the reports required by K.S.A. 25-4148, and that the Commission impose a fine pursuant to K.S.A. 25-4181, in an amount not to exceed \$5,000 for the first violation, \$10,000 for the second violation and \$15,000 for the third violation and for each subsequent violation.
